For Class 1 to Class 5 each student expense Rs 3,050 (including exercise books, school admission fee, books, exam fees, school uniform and others) (Total No. of Class 1 to 5 students is 30, the total expense is Rs 3,350 X 25= Rs 91,500)

For Class 6 or above, each student expense Rs 3,250 (including exercise books, school admission fee, books, exam fees, school uniform and others) (total No. of Class 6 to Class 10 students is 46, the total expense is Rs 3,250 X 46 = Rs 149,500)

For Class 11, each student expense Rs 7,000

(total No. of class 11 students is 3= Rs 21,000)
